

Antigua & Barbuda Environment Foundation: Scoping Report Contents Overview

Conservation Collective (CC) is a global network of 20 local environmental foundations dedicated to protecting the environment, restoring nature, and combating climate change. As a UK-based charity, CC incubates, launches, and supports locally focused foundations, unlocking new funding channels for impactful grassroots environmental projects.

CC is expanding its network by establishing the Antigua & Barbuda Environment Foundation (ABEF), aimed at preserving and enhancing the natural beauty, biodiversity, and ecosystems of Antigua & Barbuda. ABEF will act as a funding body, channeling resources from private donors, corporations, trusts, and foundations to support grassroots conservation initiatives in Antigua & Barbuda. This will be the third Caribbean-based foundation, joining sister members St Vincent & the Grenadines Environment Fund and the Barbados **Environmental Conservation Trust.**

Conservation Collective and a group of funders with strong connection to Antigua & Barbuda are looking for a consultant to conduct a comprehensive scoping report to understand the conservation needs and the civil society landscape in Antigua & Barbuda, to form the basis of a grant giving strategy. The model's value add is to create a neutral platform to build alliances with local stakeholders, foster cross-sector collaborations and turbo-charge the impact of local communities working to protect and restore nature at the grassroots.

The scoping report should be composed of three main elements:

- 1. Overview of the environmental landscape of Antigua & Barbuda: what are the key challenges, priorities and opportunities?
- 2. Positioning Piece: Conducting interviews with environmental NGOs as well as grassroots organisations active in the area, documenting key needs, opportunities, and challenges.
- 3. Feasibility Study: with Conservation Collective, identifying donors with connections to or interest in Antigua & Barbuda. Determine current funding sources of key conservation projects on the islands.

Consultant Requirements:

- Local resident or well-integrated in the area with excellent communication and writing skills.
- Proactive, highly organised self-starter with an entrepreneurial approach.
- Strong connections with government, policymakers, and businesses.
- In-depth understanding of/experience working with key NGOs operating in the region.
- Background working in the environmental sector or relevant studies.

Suggested Scoping Report Contents:







































Introduction:

- Regional overview: location, geographical area, marine boundaries, land mass, topography, ecosystems, natural disaster threats, protected areas, population, and main industries.
- o Tourism and development: Current status, impact, and future plans.

State of the Environment (ecological features, risks and threats)

- Marine ecosystems.
- Terrestrial habitats.
- Agricultural land (soil, practices, and local produce).
- Climatic events.
- o Energy.
- Waste management.
- Water resources.
- Native biodiversity.
- Key environmental challenges and their impact on local communities, including social, economic and wellbeing trends.

Current Conservation Efforts:

- Gaps in capacity, civil society, environmental action, and funding.
- Active local grassroots groups and associations.
- National and international NGOs.
- Example(s) of successful environmental campaigns
- Local experts and advisory board suggestions.
- o Level of environmental education and sense of environmental stewardship from local communities.
- Relevant national laws, policies, and local political situations.
- Existing political advocacy and lobbying efforts.
- CONCLUSION: Identification of ABEF's key Areas of Work based on the findings from the points above.

Feasibility Study of Potential Donors:

- Analysis of the local philanthropic culture (existence of fiscal incentives for donations, potential redlining issues, possibility of raising funds from outside of Antigua & Barbuda)
- Demographic analysis of potential donors (who they are, where they come from, what concerns them).
- Identification of potential leading corporate and business partners, noting any sensitivities.
- Wealthy residents or diaspora.
- o Foundations and large charities that provide grants and potential collaboration opportunities, noting any sensitivities.

Local Foundation Specifics:

Structure and key personnel (founding donors, Steering Committee, Chair).







































- Branding and logo design.
- Roadmap and vision.
- Fundraising strategy.

The consultant will be compensated a total of \$2,000 USD for the completion of this study. Payment will be disbursed in two instalments:

First installment: \$1000 USD upon completion and submission of the first draft (mid August). Final installment: \$1000 USD upon submission of the final version following feedback and revisions based on comments from founding donors.

A draft should be provided by mid-August, for the founders to review over a call. A final version, together with a short executive summary, should be delivered no later than 1st September.

Please note that successful scoping studies can lead to being considered for the role of the Executive Director of the new organisation.
